III. **Introductions**

Ms. Deborah Hawley introduced Mr. Tim Bargeron as the CFO of St. Lucie School District as well as an adjunct professor with FAU in the College of Education.

V. **Recognitions and Awards**

Ms. Deborah Hawley, Chair Ms. Debra Snyder thanked the board members for their patience and guidance through the unknowns of the first year. To show their appreciation, Ms. Debra Snyder principal of Palm Pointe Research School @ Tradition presented each member of the board a plaque as a token of support. She also gave special thanks to Ms. Deborah Hawley, Chairperson, and presented her with a gift of appreciation. A round of applause followed from all who were present.

VI. **Principal's Report**

Ms. Deborah Snyder, Principal Ms. Cortina Bell-Gray, assistant principal read aloud a letter Palm Pointe received from an 8th grade, African American, ESE, self contained emotional classroom student that qualifies free meals. This letter was a touching story of how a student overcame odds, passed the 8th grade and gained confidence in his/her ability to learn.

Ms. Lydia Martin, assistant principal discussed the test results from the FCAT summary. Palm Pointe is generally very pleased with the report. Palm Pointe's goal was to be at district standards by the first year, state standards by the second year, and above state standards by the third year. Currently the tests results form this year are above state standards, meeting year three goals.

VII. **CEO's Report**

Mr. Glenn Thomas, Exec. Director Mr. Glenn Thomas announced that the corporate reports have been filed and that the annual audit for charter schools is approaching. Mr. Glenn Thomas mentioned that the research listed in the Lab School Research Report can be showcased at the district workshops. Ms. Debra Snyder announced at Palm Pointe there are currently 40-50 individuals ready to start research projects and many of them are doing background literature reviews over the summer break.

IX. **Discussion Items**

Ms. Deborah Hawley, Chair Mr. Tim Bargeron, Chief Financial Officer, St. Lucie District Schools discussed financial issues faced by the St. Lucie School Board in the 08-09 school year that arose. Possible solutions were discussed that include a new operating agreement that assures Palm Pointe funding. Under the current operating agreement Palm Pointe receives 3 sources of funding, FEFP, Title I, and additional funding for supplemental services.

Mr. Tim Bargeron addressed the transportation issue and DOE subcontract. Ms. Debra Snyder brought to the Boards' attention possible concerns related to the National Board Teachers status.

The district predictions of 08-09 decline in enrollment though this is not the case with Palm Pointe. To date, Palm Pointe has hired 1443 staff and predicted 1487.

Factoring in transportation reimbursement, the 143 dollar per student drop in funding, the given legislation drop in funding next year, the 550 thousand stimulus loss in 2 years, there is still room in the operating budget.

Ms. Gerri McPherson requested hiring status at Palm Pointe. Ms. Debra Snyder noted that Palm Pointe has 17 open positions, 4 people have been placed and hiring 13 posted positions.

At this time there is no state funding for transportation at Palm Pointe. The district gets 50% for other schools. Palm Pointe is using the Hub Model for transportation also used by magnet schools in the district.

Ms. Gerri McPherson requested a budget overview to address long term budget reserve plan.

Dr. Eliah Watlington commended the accomplishments of the Palm Pointe teachers in one of the most challenging years in their careers. She on behalf of the board expressed her pride in the teachers and their hard work. A resolution will be drafted and signed by the board.

Ms. Debra Snyder recognized outstanding teachers.

Ms. Deborah Hawley honored Ms. Gerri McPherson with a gift of thanks. Ms. Deborah Hawley noted that Ms. Gerri McPherson is responsible for the thousands of volunteer hours invested by Ms. Hawley and played a huge part in Ms. Hawley's development and learning.

Ms. Debra Snyder also honored Ms. Gerri McPherson with a gift of thanks. Ms. Debra Snyder noted that she worked with Ms. Gerri McPherson her first year as a media specialist and throughout their time together, their paths have crossed resulting in 30 great years together. Gifts were presented, photos were taken and Ms. Gerri McPherson gave thanks all around.
